



**An informational meeting will be held on Friday, August 19th from 6:00-7:00 to explain more details about the company and what to expect in the year 2022/23.*

The **DanceQuest Performing Company** commitment will come up twice this year with two separate sessions. The first session will run September-December and the second session from January-May. You may choose to participate in only one session or both. **DQPC** members must remain enrolled in DanceQuest classes throughout the entire time of their 16 week session(s). The company is split into sub-groups by age and technical ability. Consistent attendance is imperative to the success of the dance company; therefore excessive absences will be addressed and could result in being pulled from a performance or removal from the company. Company members are also expected to maintain good attendance in technique classes in addition to company rehearsals. Company members are responsible for learning and remembering choreography. Due to the speed in which routines must be learned, practicing outside of rehearsal is a must. Dancers are required to wear proper dance attire to all rehearsals - A solid black sleeveless leotard, tan jazz shoes, and pink ballet shoes.

Required number of classes per week depends on which sub-group of **DQPC** in which the dancer is placed.

DQPC Minis (ages 5-7) - Must be registered in 1 class in addition to rehearsal

DQPC - Must be registered in 2 various dance styles in addition to company rehearsal

The company will rehearse continually once or twice a week depending on level with additional rehearsals as needed. Rehearsals will be on different nights for different levels: (Remember that these levels will be determined at auditions.)

- DQPC Mini - Monday 5:30-6:15
- Level D - Thursday 5:45-6:45
- Levels P & Q - Monday 7:00-7:30 and Thursday 7:30-8:00
- Level C - Monday 8:00-8:30 and Wednesday 8:00-8:30
